The school, which serves deaf and hearing-impaired youth, and students with multiple disabilities from ages 3 to 21, recently renovated and expanded its facilities due to rapidly increasing enrollment. Volunteers will fill the drab hallways with colorful, themed murals; paint classrooms in energetic colors; restore and secure outdoor play and learning areas; and reorganize the school's library. This project will provide a welcomed surprise for students and families as they return for the 2009-10 school year.
